We are especially proud of our partnership with Clackamas Community College, where we help train the next generation of healthcare professionals. The learning that happens between students and seasoned medical volunteers is inspiring—an exchange of knowledge, mentorship, and compassion that reflects the very heart of our mission.







AKHIL

Akhil's story is one of resilience, healing, and restored faith...in his health, in people, and in the possibility of being well again.



Akhil Kapoor spent 46 years in the restaurant business, working long hours and putting his health on hold. "It was very busy. And stressful," he said. "I wasn't able to take care of myself in a regular manner because I didn't have the means."

In 2023, Akhil's life changed dramatically—he suffered two strokes in just three hours. After emergency treatment, he was turned away from a primary care clinic due to lack of insurance. "I was fortunate enough they recommended the Clackamas Free Clinic," he said.

"It's not just about a diagnosis, it's about how to get better."

Over the next two years, Akhil met with volunteer providers who helped guide his recovery. The care went beyond lab results. Through each visit, Akhil says he felt deeply supported. It restored his hope. "The clinic does amazing work that is important for our community. If you were paying a lot at a hospital, this is the kind of care you would get."

"I wouldn't be where I am today without this clinic. They've gone above and beyond."

Now covered by Medicare, Akhil is embracing the next chapter of life with his wife — grateful for the care that got him here.
